In accordance with clause 24 of the Trust Deed of Bharathmatha Educational & Charitable Trust, the Trustees in a duly convened meeting has made the following amendments to the Trust Deed bearing Registration No. 393 of 2011 in Book IV, Volume No.430, in Pages 51 to 60 dated 28-09-2011 of the Sub Registry Office, Palakkad for getting Registration under Sec.12A of Income Tax Act.

Amendments to be carried out

In the existing clause THE OBJECTS a new clause 'a (i)' is hereby inserted as follows:-

a (i) To establish and maintain high quality educational and human resource development training organizations. All educational institutions established and administered by the Bharathmatha Educational and Charitable Trust shall be minority educational institutions covered under Article 30(1) of the Constitution of India primarily for the benefit of Christians. However, admissions in these minority educational institutions shall be extended to others as well, irrespective of religion, race, community, caste, creed, colour, sex, language and social status etc.

The capital of the trust is shall be Rs.1,00,000/- (Rupees One lakh only) at present and this deed of amendment shall be treated as the part of the Trust deed No.393/2011 of Bharathmatha Educational and Charitable Trust and the stamp duty is paid a sum of Rs.15,000/- as per the present provision.
